RELATIONSHIP WITH LAW ENFORCEMENT AGENCIES

Community Living-Central Huron will treat all persons supported with dignity and respect, however does not condone or support unlawful activity.

Definitions:

Law Enforcement: is any system which some members of society act in an organized manner to enforce the law by discovering, deterring, rehabilitating or punishing people who violate the rules and norms governing that of society.

Unlawful: not conforming to, permitted by laws or rules; illegal.

Community Living-Central Huron:

- a) Recognizes that all community members are subject to the same laws.
- b) Provides information, as appropriate, to people supported on the possible consequences of illegal activities and/or any failure/breach to abide by court issued directives.
- c) Supports law enforcement agencies in the prevention and detection of unlawful activity, with respect to the rights, as per law, afforded to people supported.
- d) Will assist people supported to be aware of and to access appropriate services, should they be investigated for or charged with unlawful activity.
- e) Will report court issued breaches to the relevant court, probation and parole or law enforcement agency.
- f) May utilize the services of law enforcement agencies, probation and parole, and court representatives in a consultative or educational manner, in the best interests of the people supported.
